NOTE-3: All the learned law officers are requested to make available to the Advocate General judgments (downloaded from the High Court website) in at least two cases argued by them.

NOTE-4: The Learned Law Officers are hereby requested to **strictly** adhere to the Work Allotment given to them. It is not permissible for a Law Officer to mutually negotiate and change the work allotment without the prior consent of the Advocate General. Such requests for change in work allotment are to be made only to the Advocate General. **It is hereby informed that the concerned Law Officer will be held accountable and responsible for the cases allotted to them.**
