- NOTE-7: The Law Officers are requested not to avail leave without the prior permission of the Advocate General. In urgent cases, such requests may be made at least <u>one day</u> earlier in writing.
- **NOTE-8:** Depending on the need of sitting arrangement, the present allocation could be changed and would be notified.
- **NOTE-9:** Law Officers would deliberate & communicate as to their functioning & difficulties, if any, with Advocate General, at least once in a month.
